## Golden Seal 500mg: Cultivated Quality

Golden Seal is a plant native to North America. The first written therapeutic reference to the use of the plant by Native Americans was by the medical botanist Benjamin Smith Barton in 1798.<sup>1</sup> Authentic Golden Seal (*Hydrastis canadensis*) root and rhizome contains the important constituents: hydrastine and berberine. (There are many herbs that contain berberine, but only *Hydrastis canadensis* contains hydrastine. Hydrastine and berberine are alkaloids.) Golden Seal has a bitter taste and is conveniently dispensed in tablet form.\*

### King of mucous membrane tonics

Natural clinicians in the late 19th-century United States were especially enthusiastic about Golden Seal. They regarded it as specifically advantageous to the mucous membranes: promoting health in the membranes and maintaining healthy mucus.<sup>2,3</sup> Golden Seal was referred to as ‘the king of tonics to the mucous membranes’.<sup>4</sup> As a mucous membrane tonic, natural clinicians use Golden Seal to improve the tone, vigor and function of the mucous membranes.\*

### Mucous membranes

Mucous membranes are located on the lining of body cavities (eg digestive tract, respiratory tract, reproductive tract). They are designed to protect delicate body tissues that have some exposure to the outside world. Here are some examples of what mucous membranes do:<sup>5</sup>

- Inside your nose is a series of structures called turbinates. When you breathe, the air is forced over the turbinates (the shape creates turbulence in the breathed air). Each turbinate is covered with a mucous membrane, which has two functions: (1) to trap dust and other particles, and (2) to warm and humidify the air. Because your mouth doesn’t have this feature, breathing (dry) air through your mouth all night results in a sore throat in the morning.
- The mucous membranes in the small intestine pump out enzymes and mucus (thick secretion that acts as a lubricant and protectant for the intestinal wall).\*

## How Golden Seal 500mg Keeps You Healthy

### Supports health in the gastrointestinal tract

Golden Seal supports health in the stomach and intestines. In addition to supporting healthy gastrointestinal mucous membranes, Golden Seal promotes digestive enzyme function, healthy digestion and healthy bowel movements. Golden Seal has also been used traditionally to provide a cleansing action in the gastrointestinal tract.<sup>1,4\*</sup>

### Helps maintain healthy breathing passages to support free and clear breathing

By maintaining healthy mucous membranes, for example encouraging normal secretions in the nasal passages,<sup>3</sup> Golden Seal supports free and clear breathing.\*

## Why use herbal products from an environmentally-responsible manufacturer?

Herbal products are made from living plants. It is extremely important that as consumers and manufacturers we do all we can to ensure their sustainability. Many species are threatened by destruction of their habitat and by unsustainable harvesting. One such example of this is the wild crafting (collecting from the wild) of *Hydrastis canadensis* in the United States.\*

In June 1997, Golden Seal was included in the Convention of International Trade in Endangered Species (CITES). This means that the international trade in Golden Seal is regulated and monitored to help ensure the plant's survival.<sup>1</sup> However, CITES regulations do not monitor the trade of Golden Seal in the US, so it is vital that you ensure any Golden Seal product you choose is from a cultivated source. MediHerb has a strong policy on endangered and threatened medicinal plants, and only purchases cultivated sources of Golden Seal root and rhizome.\*

## Why use top quality herbal products from a reliable manufacturer?

Consumers need to be confident of the integrity of the herbal manufacturer to ensure that the product contains the stated amount of important constituents and that the authentic plant is used.\*

Back in 1912, many species other than the genuine *Hydrastis canadensis* were reportedly traded in the US as Golden Seal, including Barberry (*Berberis vulgaris*), Oregon Grape (*Mahonia aquifolium*, *M. nervosa*, *M. repens*) and Chinese and American Goldthread (*Coptis* spp.). Another common adulterant is the leaves and stems of Golden Seal itself.<sup>1</sup> Adulteration and/or poor quality continues still today due to its popularity, high market value and recent threatened status.\*

In 2007, analysis of six Golden Seal root products obtained in Tennessee found that only two of them had quantities of alkaloids (berberine and total alkaloids) in agreement with their labels. There was considerable variation among the products in terms of the alkaloids present and the quantity of alkaloids: only two products contained hydrastine. One product had an alkaloid pattern that strongly suggested the presence of at least one additional herb, not declared on the label.<sup>6\*</sup>
