



Gymnema 4g

Gymnema leaf has been used by natural clinicians in India for centuries to support healthy blood sugar levels.^{1,2} In India, it has a common name Gurmar, meaning 'destroyer of sugar', perhaps because the taste of Gymnema suppresses the ability to detect sweet tastes.^{3,4} The important plant constituents of Gymnema are the saponins, especially the gymnemic acids.^{4*}

How Gymnema 4g Keeps You Healthy

Gymnema helps maintain a healthy pancreas and helps support healthy blood sugar levels

Gymnema extracts containing an appropriate amount of saponins (gymnemic acids) help maintain a healthy pancreas. This supports healthy pancreatic function and the normal production of insulin in the body. Gymnema may do this by supporting the integrity of the pancreatic beta cells.¹ (These beta cells produce insulin. Insulin removes glucose from the blood and helps with the storage of glucose (as glycogen and fats), thereby helping to regulate the supply of energy.)^{*}

When combined with a balanced diet, Gymnema supports healthy blood glucose levels within a normal range.¹ As well as supporting the pancreas, Gymnema also promotes normal absorption of glucose from the intestine and a healthy metabolism.^{5*}

Gymnema helps maintain healthy cholesterol levels

While supporting healthy glucose metabolism, Gymnema may also help maintain cholesterol and triglycerides in the blood within a normal range.¹ A healthy diet (low in saturated fat and refined carbohydrates) combined with regular exercise and healthy cholesterol and glucose levels helps maintain metabolic and circulatory systems.^{*}
